## TERMS AND CONDITIONS OF HIRE

### MAXIMUM PASSENGER CARRYING CAPACITY FOR HUMMER - 14

#### CONDUCT OF PASSENGERS:

1. Any passenger whose conduct is abusive, unruly, or intoxicated, may be removed from the vehicle or prevented from boarding the vehicle on the driver's authority.
2. The Client will be responsible for the conduct of passengers and for any damage caused to the vehicle by passengers during the hire, be it accidental or intentional.
3. The driver may terminate hire without refund and/or remove alcohol where the driver believes customers are intoxicated or acting in an unruly manner.
4. Cost to sanitize the interior of the vehicle commences at \$250 and increases depending upon extent of the problem.  
The cost will be charged to the Clients Credit Card or paid by cash.

#### BOOKING TIMES:

1. The Client agrees to adhere to their booked start and finished times and accepts that any overtime, caused by them, will be charged accordingly.
2. Overtime will be charged at the hourly rate, or part thereof.
3. Refunds will not be given upon early completion of pre-booked times.
4. We do not accept responsibility for lateness caused by the client.
5. Quote is for One/Two pickup location only.
6. Each extra pick-up will incur an additional fee.
7. Allow time for "Happy snaps"

#### FOOD & BEVERAGES:

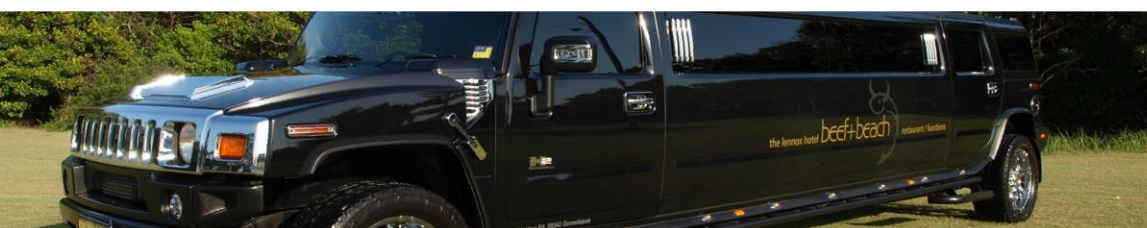
1. After complimentary drinks (if applicable) are consumed, any additional beverages will be at the Client expense.
2. ALCOHOL CANNOT BE CONSUMED BY PERSONS UNDER THE AGE OF 18
3. No food is to be consumed in the vehicle without the knowledge and consent of the driver.
4. Passengers must remove all rubbish on exiting the vehicle. A fee may be charged if the vehicle returns in an unreasonable state.

#### SMOKING:

1. Strictly NO smoking in the vehicle. This includes any illicit drugs or narcotics.

#### FINANCIAL:

1. Any deposit paid by the Client is deemed as an acceptance of these Term and Conditions.
2. All deposits re non-refundable and to secure the vehicle, are due within 7 Days of Booking unless prior arrangements have been made.
3. The Client agrees to pay the balance owing 7 Days prior to the booked date by direct debit, cheque or money order, unless prior arrangements have been made.
4. We will not be held responsible by any person or persons, company or syndicate for injuries sustained and are absolved from any and all liabilities.

## **OVERTIME AND WAITING TIME:**

1. Waiting time or overtime rates are applied at 15 min increments after the first 15 minutes.
2. Unless previous arrangements are made, these costs will be charged to your credit card.

## **SAFETY, BELTS AND CHILDREN:**

1. Your safety is very important to us. For this reason it is compulsory to wear seatbelts provided.
2. Children under 4 years may travel in our vehicle however there are no provisions for them.

## **PHOTOS:**

1. You acknowledge that photos taken may be used for future promotion or advertising purposes.

## **VEHICLE PICK-UP TIMES & AVAILABILITY OF VEHICLE:**

1. We will endeavour on our part to always honour requested pick-up times. However, should our vehicle be delayed for any reason beyond our control, we shall not be held liable for any difficulties or extra cost arising from such delays.
2. Due to the length of the limousine, access to some streets or areas may be restricted. Therefore pick-up or drop-off at exact desired location may not be achievable.

## **DAMAGES:**

1. Any loss or breakages to supplied glasses.
2. Any loss or damage to fixtures (Screens, players, seats etc).
3. Any loss or damage to utensils, CDs, DVDs, or remotes.
4. Payment for any damages to vehicle is to be made by credit card, or cash, at the time of hire

## **CANCELLATIONS:**

1. The Client agrees that the cancellation of a booking will result in forfeiture of the deposit, if within 14 days of date booked.
2. Strictly NO REFUNDS if cancelled within 7 Days of the booked date (at manager's discretion)

## **PRIVACY POLICY:**

1. All personal information collected by us is treated in the strictest confidence and will not be disclosed in full or in part to Anyone other than us, booking and billing.
2. At any time, you may request to view your personal information collected and recorded by us.

## **CONFIDENTIALITY AGREEMENT:**

1. When signing the terms and conditions, you agree to keep confidential any and all information provided to you by us, as it is considered to be industry sensitive. This includes all information regarding service provided and prices quoted.
